## **PURPOSE**

The purpose of the Swimming Pool & Hot Tub Policy is to establish guidelines regarding the installation and use of swimming pools and hot tubs on properties owned and operated by the Hastings Local Housing Corporation (HLHC).

## **SCOPE**

The policy applies to all persons including, but not limited to; tenants, members of tenants' households, visitors and or guests, of any unit owned and operated by the Hastings Local Housing Corporation.

#### **DEFINITIONS**

"Hot tubs", also referred to as spas or whirlpools, are not permitted on HLHC property. The term "swimming pool" is used to refer to "wading pools" which are defined as a small portable container of shallow water in which small children can wade and play. Actual swimming pools are not permitted on HLHC property.

## REQUIREMENT

The Hastings Local Housing Corporation has a requirement to provide a safe and healthy environment for the Tenants. The policy will provide clear language to ensure consistency across HLHC properties.

# **PRINCIPLES**

- The pool must be above ground.
- The pool must be no deeper than 11 inches (27.94 cm).
- The pool must be no larger than 79 inches (200 cm) in diameter (across).
- The pool must be setup on your leased premises, not in the common area or public space.
- The pool must be emptied when not in use.
- There must be adult supervision if there is water in the pool.
- You must have tenant insurance coverage in the event of an accident.
- The pool must be operated according to manufacturers' specifications and recommendations.
